- Submitted papers must NOT have been previously presented, scheduled for presentation, published, or accepted for publication by any other source (journal, publisher or any other organization).

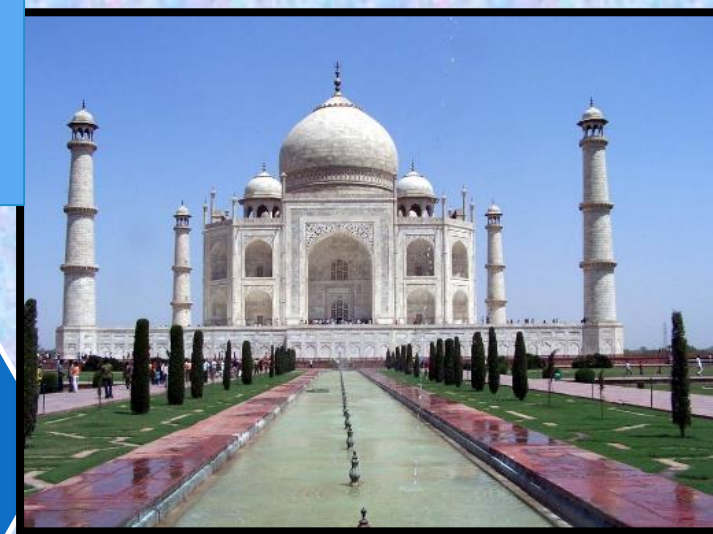

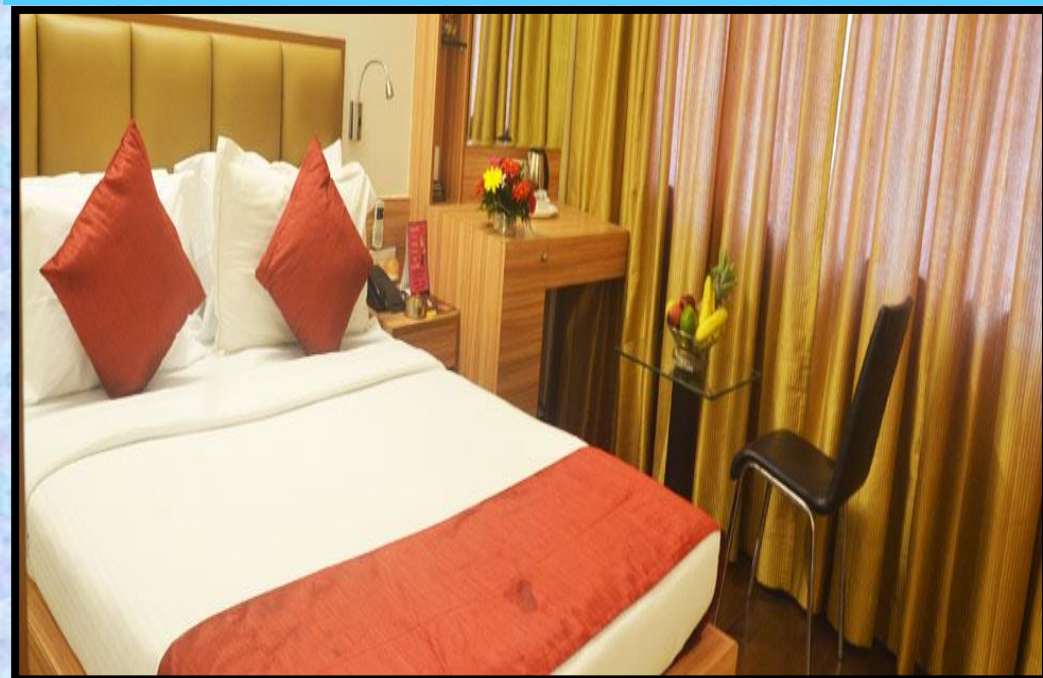
Post conference tour

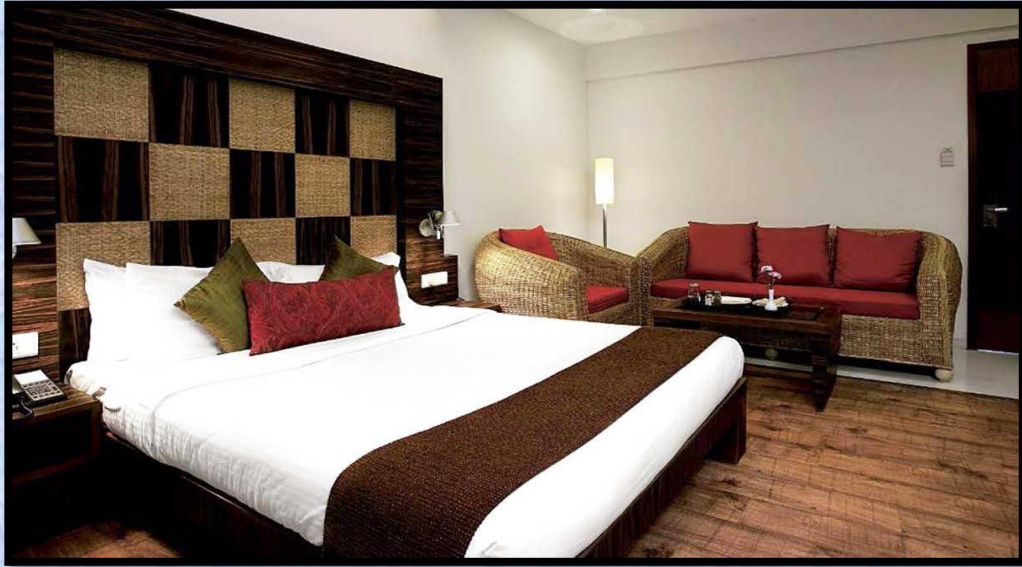

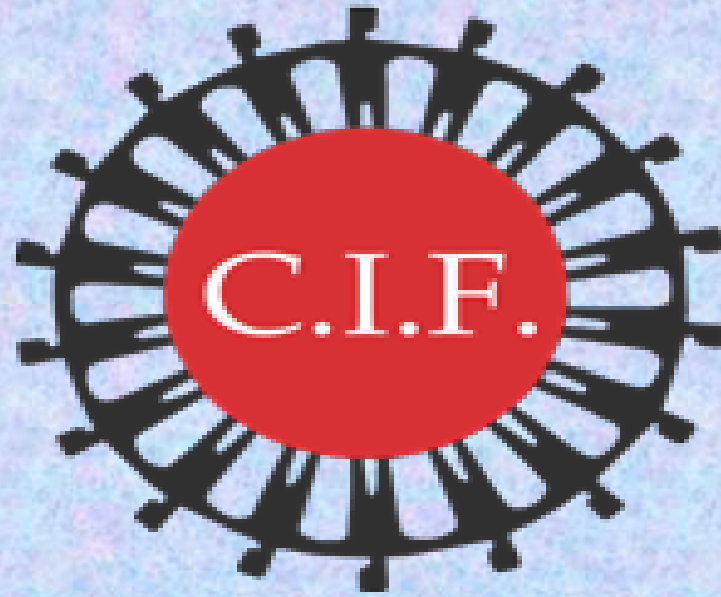
Government hotel at a good discount rate but booking only through email and payment can be done while check in the hotel. They do not have web site but you can see it on booking sites
